Objective: To conduct a Free Legal Aid Camp and provided free one-time consultation to the underprivileged section of the society to help them resolve their legal grievances.

Description: The Legal Aid Centre of the college successfully organized a Legal Aid Camp aimed at offering free one-time legal consultation to the residents of the college vicinity. The initiative was part of the Centre's ongoing commitment to community welfare and legal awareness.

Preparations for the camp began a month in advance. During this time, students of the Legal Aid Centre actively conducted door-to-door surveys in the surrounding areas to identify the prevalent legal issues faced by the community. Based on the survey findings, it was revealed that the majority of people were dealing with property, criminal, family, and employment-related issues.

Accordingly, expert practicing advocates were invited to the camp to provide tailored legal guidance:

- Adv. Anoop Mehta offered consultation on property-related legal matters.
- Adv. Uttam Dubey also addressed property issues along with other civil disputes.
- Adv. Archit Manurkar provided assistance on family law matters, such as disputes related to marriage, custody, and domestic issues.
- Adv. Vanshaj Puri advised attendees on employment-related issues, including workplace disputes and labour rights.

Outcome: The camp witnessed active participation from the local community and proved to be a significant step in bridging the gap between legal services and the common people. It not only provided much-needed legal assistance but also instilled a greater sense of awareness among the people.
