This is to inform that the final extension is allowed to all the students who are eligible and have not processed the scholarship or freeship on MAHADBT Portal. College Scholarship desk is available on **Tuesday, Thursday & Saturday** every week between 11.00 am to 01.30 pm. Students who are facing problems are required to reach on given days.

The students are required to fill online form for Scholarship / Freeship on <https://mahadbt.maharashtra.gov.in/login/login> and submit it in college office.

**Application acceptance (Fresh/Renewal) Academic Year 2025-26 will continue until 14<sup>th</sup> March, 2026.**

**The eligible students who fails to apply will be liable to pay the full fees to the college.**

Also, note that those students who have not availed benefit of Fee Concession at the time of admission can also apply through same portal to take benefit of the scholarship / Freeship schemes of Government of Maharashtra.

Students who have applied on MAHADBT portal shall bring their application form with all relevant documents to the College Office on dedicated days mentioned above for verification and Approval.
