SEMESTERS I TO IV OF 3 YEARS COURSE AND SEMESTERS I TO VIII OF 5 YEARS COURSE):

AS PER THE INSTRUCTIONS OF THE UNIVERSITY OF MUMBAI, THE FOLLOWING COLLEGES AFFILIATED TO THE UNIVERSITY OF MUMBAI HAVE BEEN FORMED INTO A CLUSTER NO. 1. KISHINCHAND CHELLARAM LAW COLLEGE SHALL BE THE LEAD COLLEGE OF THIS CLUSTER NO. 1.

Guidelines for the Online ATKT exams.

- Examinations of Semesters I to IV of the Gen. LL. B. (3 years) course and of Semesters I to VIII of the B.L.S. / LL. B. (5 years) course shall be conducted for the students of the Academic Year 2019-20 and also for the students of earlier batches (backlog/ ex-students) who were eligible to appear for the March/ April 2020 ATKT Examination.
- 2. These exams shall be conducted from 25th November to 12th December 2020.
- 3. The Timetable for these ATKT exams shall be shared in due course.
- 4. The exam shall be of the entire syllabus as prescribed by the University of Mumbai.
- 5. Only students who have duly filled the examination forms are eligible to appear for this ATKT examination.
- 6. The colleges shall allot Seat Numbers to all such students.
- 7. The exams shall be held online. Details of the mode shall be shared in due course.
- 8. Students must make requisite arrangements to appear for the online examination. (I.e. Smartphone/ Laptop/ Desktop/ any other gadget/ Internet Connectivity)



- Students must make sure that they fill up the "Student Information Form" distributed by the colleges - https://forms.gle/csXx7EoLshhCrj827
- 10. Students must ensure that they make themselves aware of the syllabus, paper pattern, timetable and the technical platform used by the college.
- 11.Two MOCK TESTS (PRACTICE EXAMS) of 5 SAMPLE MCQs each shall be conducted before the ACTUAL EXAM. One on Monday 23rd November, 2020 & another on Tuesday, 24th November, 2020 from 11:00 a.m. to 12:00 noon.
- 12.In case of any difficulties in the MOCK TESTS (PRACTICE EXAMS), the students can call on the HELPLINE number 8356829964 or email at abacollegeoflaw@gmail.com.
- 13. The ACTUAL EXAM shall be in the form of 25 Multiple Choice Questions (MCQs) for each subject.
- 14.All 25 MCQs shall be compulsory. There shall be no optional questions.
- 15. Each MCQ shall be of 2 marks and total marks of each subject shall be 50 marks.
- 16. These marks shall be converted into 100/60 marks as applicable to the respective batches.
- 17. The duration of each exam shall be 1 hour.
- 18. Students should call on HELPLINE number **8356829964** in case of any queries before and during the time of examination.
- 19.In case any student is unable to attempt the online ACTUAL EXAM due to network issues, he/she should inform the college via email within 2 hours from the time of the exam.
- 20. Students shall not resort to the use of unfair means while attempting the online examination. Strict action shall be initiated against such students for use of unfair means as per the University Rules & Regulations.
- 21. The results shall be declared by the colleges as directed by the University of Mumbai.
- 22. Since this is an online MCQ examination, there shall be 'NO REVALUATION' of assessments.
- 23. Necessary facilities for STUDENTS WITH DISABILITIES shall be provided as per the rules of the University of Mumbai. (Extra time of 20 minutes, Writer/Helper with prior approval from college, etc.) If any DISABLED/ PH student needs a Writer/Helper, he/she must email an application to the respective college stating qualification and details of the Writer/Helper.
- 24.A meeting of all the students who are eligible to appear for the ATKT/ Backlog Exam of March/ April 2020 will be held on Thursday, 19th November 2020 at 1:00 pm. The link for the same shall be shared in due course.
