Courses Offered

We at Adv. Balasaheb Apte College of Law have introduced 5 and 3 years degree courses in Law. Admissions to 5 years degree course in law can be taken after passing H.S.C. Board examinations from any discipline and obtaining the required score at the MH-CET (Law). Admissions to 3 years degree course in law can be taken after passing Degree examinations from any discipline (prescribed in the pattern of 10+2+3) and obtaining the required score at the MH-CET (Law).

Eligibility for Admission

The College follows eligibility criteria as specified by the Director of Higher Education, Government of Maharashtra. Students are requested to refer to the website of the Government of Maharashtra http://www.mahacet.org/, or the college website www.abalawcollege.com or the college notice board from time to time for details and updates in the matter. Students who have passed H.S.C. or equivalent or Degree examinations (prescribed in the pattern of 10+2+3) from any stream, with 45% or above marks and have obtained the required score in the MH-CET (Law) are eligible. However, the above percentage of marks shall be relaxed by 5% for candidates belonging to the Reserved Category. IB students have to submit the predicted grade and certificate of conversion of grades into percentage if their result is not declared at the time of submitting the admission form. Enrollment to the roll of Advocates shall be subject to the approval and rules of the Bar Council of India.

Prohibition to register for two regular courses of study

No student shall be allowed to simultaneously register for a law degree programme with any other graduate or post-graduate or certificate course run by the same or any other university or an institute for academic or professional learning excepting in the integrated degree programme of the same institution.

Provided that any short period part time certificate course on language, computer science or computer application of an institute or any course run by a Centre for Distance Learning of a University however, shall be accepted. (Rule 6, Rules of Legal Education 2008, Bar Council of India.)



Admission Form and Documents Required

Application forms for 5 years and 3 years degree courses & prospectus are available on the college website. Forms duly filled in must be submitted to the College office. Admissions are based on merit.

Students are required to confirm the admission in person by submitting the following certificates with the application form:

- 1) Original Allotment Letter issued by the State CET Cell.
- 2) Original CET Score card and CET Hall ticket.
- 3) Std. X Mark sheet & Passing Certificate (Original, One attested photocopy & Two Non Attested photocopies.)
- 4) School Leaving Certificate (Original, One attested photocopy & Two Non Attested photocopies.)
- 5) Std. XI Mark sheet (Original, One attested photocopy & Two Non Attested photocopies.)
- 6) Std. XII Mark sheet & Passing Certificate (Original, One attested photocopy & Two Non Attested photocopies.)
- 7) Std. XII Leaving Certificate (Original, One attested photocopy & Two Non Attested photocopies.)
- 8) Degree mark sheets (All Semesters), Degree Passing Certificate, Degree Certificate- for 3 Year Course (Original, One attested photocopy & Two Non Attested photocopies.)
- 9) Degree Transfer Certificate.
- 10) If the student is from other than Maharashtra State Board, he/she should submit the following additional documents: -
 - (a) Original Migration Certificate from the Board/University which he/she passes the examination and an attested photocopy thereof.
 - (b) A copy of the Provisional Eligibility Certificate and Enrollment Registration Form from the University of Mumbai, duly signed.
 - (c) A Provisional Eligibility fee of Rs. 320/- to be paid in cash at the time of admission.
- 11) Caste Certificate, Caste Validity Certificate, Non Creamy Layer Certificate if applicable. (Original, one attested photocopy & Two Non Attested photocopies.)
- 12) Domicile Certificate/Birth Certificate/School Leaving Certificate mentioning Place of Birth.
- 13) Two (2) recent passport size photographs. (One photograph to be affixed on the Admission Form)
- 14) In case of a student from a college affiliated to the University of Mumbai, No Objection Certificate (NOC) from that college.
- 15) Foreign students seeking admission should produce their passport & student's visa at the time of admission. Students on tourist visas will not be admitted to the college.
- 16) Married female students should produce attested true photocopy of a marriage certificate or in case of change of name, they should produce an affidavit and an attested true photocopy of gazette publication.
- 17) Undertaking to attend a minimum of 75% of the total number of lectures held during each semester as per University Regulations.



- 18) The Principal should be informed in writing about any change in the information submitted by the student in the admission form.
- 19) If subsequently it is found out that any statement of the applicant is incorrect or false, his/her admission is liable to be cancelled without refund of fees.
- 20) Students from Universities other than the University of Mumbai will be admitted provided that the examinations of the other Universities are considered equivalent and are subject to the provisions of eligibility conditions of the University of Mumbai.

Important Note: Original documents, along with the prescribed fees to be submitted as per the provisional admission schedule put up on the college notice board from time to time. Students shall be informed to submit additional documents to the college as and when required by the Department of Higher Education.

Fees

The fee for the First Year of five years course is Rs. 24000/- and for the three years course is Rs. 30000/-. The fees shall be subject to change, depending on the directives from the University of Mumbai and subject to the approval of the concerned authorities. Full fees must be paid along with the required deposit amounts at the time of admission. No student will be permitted ordinarily, to appear for any of the University/College Examinations if he/ she has not paid the College/Examination fees for the year. Fees and other dues shall be payable as prescribed from time to time by the competent authorities.

Payment of Fees:

Fees to be paid online through our college website or by Demand Draft/Pay Order in favor of 'ADV. BALASAHEB APTE COLLEGE OF LAW'

Refund of Fees:

Fee Deduction on Cancellation of Admission shall be as per the prevailing rules of the State CET Cell. Students are advised to preserve their fee receipt carefully. Refunds of deposits/admission cancellation fees will be made only by cheque on submission of the original fee receipt. A duplicate fee receipt may be issued on payment of Rs. 50/- with the special permission of the Principal. Caution Money and Library Deposit amount will be refunded to the students from 1st August to 30th September on completion of the 5 year and 3 year course.

Attendance:

Students must attend lectures, practicals, tutorials, etc. as per the Time-Table. They must not abstain themselves from classes, practicals, tutorials, examinations etc. without written permission of the Principal. Students whose attendance, progress in various tests and examinations are not satisfactory and who do not attend the required number of tutorials and / or practicals are likely to lose their terms. Students who do not submit compulsory project work in any subject are likely to lose their term. Prolonged absence even on grounds of ill health may also lead to loss of terms. Defaulters will not be allowed to appear for the University Examinations.

Examination:

Standard for passing the Examination shall be as per the ordinance passed from the University of Mumbai. If a candidate is allowed to join the next higher class as provided in the Ordinances relating to the different examinations, he will not be permitted to appear for the high examinations unless (i) he has previously passed in the remaining subjects of the lower examination, or (ii) he appears in that subjects simultaneously with his appearance at the higher examinations. In the latter case, however, he will, in no circumstances be considered to have passed in the higher examination, or any part of it, unless he passes in the aforesaid subjects (with the percentage, if any, required for the total) at the same time or within two years of his obtaining the marks necessary to pass in the higher examination or any part of it in which separate passing or exemption is permitted by the Regulation.



When a candidate owing to his failure to pass in the remaining subjects of the lower examination within two years is not considered to have passed the higher examination or any part of it, he will forfeit all benefits occurring from the marks obtained by him in the higher examination, but the terms kept by him for such higher examination will be available to him for any further appearance at the examination.

No candidate will be admitted to, and allowed to appear at, the year-end semester examinations unless he/she has successfully passed the Examination in the Practical Training papers for the respective semester to be conducted by the respective colleges affiliated to the University of Mumbai, on behalf of the University.

Term Grant and Examination:

To keep a term at a college or recognized institution, an undergraduate must complete to the satisfaction of the Principal or the Head of the institution, the course of study at the college or institution prescribed for such terms for the class to which such undergraduate then belongs.

Although illness or other serious circumstances may be considered valid for the absence at lectures, tests, tutorials; the circumstances cannot condone a student for poor performance or absence and exempt them from appearing for examinations. Accordingly, students with poor records of academic performance will not be granted terms.

Students who have not been granted a term will not be permitted to appear at the First Term/ Second Term/ Annual Examination conducted by the College or by the University.

The University of Mumbai will hold the examinations at the end of Semester IX and X for the 5 year course and Semester V & VI for the 3 year course. Additional practical/internal examinations shall be conducted as per the rules of the University of Mumbai.

Library:

The College library will remain open from 8.00 am to 5.00 pm on all working days from Monday to Saturday.

- 1) Text-book section stocks recent editions of Textbooks, Bare Acts, and University Examinations Question Papers etc.
- 2) Students can borrow textbooks for home reading from lending section.

 The rules & regulations of the library will be provided to the students separately.
- 3) Ex-students of the college will be permitted to use the library reading hall with prior permission from the Principal on payment of a library fee of Rs. 500/- Per annum.

Identity Card:

Every Student must wear the Identity Card as long as he/she is on the College Campus. It must be produced by the student whenever demanded by a member of the teaching or non-teaching staff of the College. She/he must take proper care to avoid its misuse by other students and outsiders. In case the Identity Card is lost, the matter should be immediately reported to the Principal and an application should be made for a duplicate Identity Card which will be issued on payment of charges.



Discipline:

- 1. No society or Association shall be formed in the College and no person should be invited in the College campus without the specific permission of the Principal. The Principal has a right to refuse such permission.
- 2. All meetings, cultural programmes, debates, elocutions, moot-court etc. organized on the College Premises must be held in presence of teaching staff members and with the prior permission of the Principal. The subjects of debates / elocutions / moot-courts must have the prior approval of the Principal.
- 3. Students involved in malpractices at the College / University Examinations will not be admitted to the College.
- 4. Students shall not do anything inside or outside the College that will interfere with the discipline of the College or tarnish the image of the College or of the other students.
- 5. Smoking is strictly prohibited on the College Premises.
- 6. If, for any reason, the continuance of the student in the College is found detrimental to the best interest of the College, the Principal may either ask the student to leave the College without assigning any reasons or refuse to admit the student for the next academic year; and such decision will be final and binding on the student.
- 7. Acts of Misbehavior, Misconduct, Indiscipline or Violation of the Rules of Discipline mentioned above are liable for one or more punishments as stated below:
 - a. Warning to the student.
 - b. Warning to the student as well as a letter to the parents.
 - c. Imposition of a fine.
 - d. Denial of gymkhana, library, N. S. S., student-aid or any other facility for a specified period or for the whole Term/Year.
 - e. Cancellation of Terms.
 - f. Refusal of admission in the next term or academic year.
 - g. Cancellation of Admission.
 - h. Expulsion from the College for a specified period.
 - I. Rustication.

Ragging:

Ragging is strictly condemned and prohibited in this college. The aggrieved students are requested to report the same to the Anti-ragging Committee to take speedy action. The guilty shall be dealt with harshly and severe action as demanded by the situation shall be taken against them as per the provisions of 'Maharashtra Prohibition of Ragging Act, 1999' and the directions issued by the Courts.

Women's Development Cell:

The college has a College Women's Development Cell duly constituted as per the Vice-Chancellor's Directions bearing No. WDC/VCD/240 of 2008 issued by the Hon. Vice-Chancellor of the University of Mumbai.



In his address he stressed the need for reducing the burden on the courts and resorting to alternative methods like Conciliation and Mediation.

The main session on 'Understanding Alternative Dispute Resolution' by eminent speaker Hon'ble Smt. Justice Roshan Dalvi, Former Judge, Bombay High Court was very enlightening. Her ladyship explained to the audience the various methods and practical aspects of alternate dispute resolution and reiterated the need for resorting to mediation.


A question answer round was conducted, and her ladyship responded to all the queries of the participants.

Media & Communication Law

The course was well received and resulted in a memorable & knowledgeable experience for the students.

I/C Principal Vaishali Gurav addressed the freshly inducted students of first year with warm greetings and welcomed them to the college virtually, introducing faculties and non-teaching staff.

MOOT COURT SOCIETY:

Panel Discussion on "The Contempt Law in India"

The Moot Court Society for the first time conducted an online panel discussion for the students on the topic "The Contempt Law in India". There was attendance and participation from students of all the batches studying in the college. The main purpose of holding the discussion was to enable students, especially freshers, to speak up and to hone their skills to reason and support their arguments. The event was conducted in April 2020.

Online Moot-Court Competition

The 1st Intra Collegiate Online Moot Court Competition was hosted from 25th July to 29th July 2020. A total of 118 students participated who were divided into 2 Pools based on the Year they studied in. The topic for Pool A was based on Kidnapping of a Minor while Pool B was based on problem framed around Juvenile Justice Act. The Pool A preliminary rounds were judged by Advs. Akshay Pai, Siddhi Bhosale, Uttam Dubey, Parth Sangrajka Sudhanva Bedekar and Arjun Kadam while Pool B preliminary rounds were judged by Advs. Nishant Tripathi, Vikrant Parshurami, Shantanu Phanse and Akshay Pai. The Semi-Final rounds for Pool A and B were judged by Dr. Krishna Shetty and Dr. Aashish Borse respectively. The Finals of the competition were adjudicated by Advs. Ashish Chavan and Aloukik Pai. While Vyomesh Warunjikar and Tirtha Pawar from First Year BLS/LLB were declared winners of Pool A, Vrutika Jain and Shriya Nair from Fifth Year BLS/LLB won the Pool B round.







The 8th Annual Adv. B. P. Apte Memorial National (Virtual) Moot Court Competition

The 8th Annual Adv B. P. Apte Memorial National (Virtual) Moot Court Competition was conducted between 25th September 2020 to 27th September 2020. The Flagship and the most Prestigious event of the institution is every year held in three parts i.e. a Mock Trial, a Moot Court and a Judgement Writing Competition. However, due to unprecedented crisis prevailing due to COVID-19, the event was shortened to only Moot Court Competition and was conducted Online for the first time in its history. One of the most challenging aspects of this year's event was maintaining the smooth flow of event where participants were safe at their homes in different parts of the country while the whole event was conducted in Mumbai. The theme for this years' competition was a Constitutional Challenge to Section 2(c)(i) of the Contempt of Court Act, 1971. A total of 46 teams participated in the event from 16 states in the country. The Preliminary Rounds were judged by Advs Abhishek Walwaikar, Ashish Pawaskar, Vikrant Parshurami and Ashutosh Gole. The Quarter Final Round was judged by Advs Aloukik Pai, Vishal Kanade, Abhay Anturkar and Nikhil Vaze. The Semi Final Round was adjudicated by Senior Advocates Sanjiv Gorwadkar and Rajendra Pai. The Finals of the Competition was by tradition graced by presence of Hon'ble Shri Justice Nitin Jamdar, Senior Judge, High Court of Judicature at Bombay who also judged the Final Rounds.

The Tamil Nadu Dr. Ambedkar Law University (School of Excellence in Law), Tamil Nadu's team, comprising of Mr. Manjunath Karthikeyan and Ms. Aparna Raju were declared winners of the competition while the team from SVKM's Pravin Gandhi College of Law, Mumbai's team comprising of Ms. Nimrah Sayani and Ms. Madhuli Kango were declared as the Runner-up Team. Symbiosis Law School, Noida's team consisting of Mr. Anmol Mathur and Ms. Priyanshi Rastogi were awarded the Best Memorial Award while Ms. Nimrah Sayani from SVKM's Pravin Gandhi College of Law, Mumbai was declared the Best Speaker.







Panel Discussion

Two Panel Discussions were conducted with the students online on 10th April 2021 and 3rd July 2021 on the topics "Contempt of Court Laws in India" and Introduction to Intellectual Property Laws". The Members of the Moot Court Society of College formed the Panel in both the discussions who provided students with a holistic view of both the topics. The Discussions enlightened the students on both these trending topics while it was very exhilarating to witness divergent views of the Panelists converging into one firm opinion.

Quiz Competition


LITERATURE COMMITTEE


'On My Bookshelf"




