Students who have been allotted this college in the Institutional Level Round (A-CAP Seats) should report to the college on Wednesday, 30<sup>th</sup> November, 2022 between 10.30 a.m. & 12.30 p.m., Admission shall be confirmed on Inter-Se-Merit in Reporting Candidates in the Merit List, failing which, the seats shall be allotted to the next student as per the Inter-Se-Merit list published by the State CET Cell, which is displayed on the notice board & college website. The Merit list shall be declared daily for days of Admission of Institutional Level Round.

The students appeared in the daily Merit List and not report to college in stipulated time will forfeit the claim on the seat, hence they will be considered in the waitlist on last day of Admission if seats available.
