**Students are required to include following components in their Journal:**

**Component no.1: Moot Court - 30 marks**

- 1) **Memorial part:** Students should write Facts of Case, Issues, Arguments (Petitioner or Respondent as case may be) and Prayers
- 2) **Oral submission:** 5 mins for Petitioner, 5 mins for Respondent, 3 mins for Rebuttal (by Petitioner, if any)

**Component no. 2: Court Visit - 30 marks**

Students should write detailed report on One Civil and One Criminal case which they have attended in Court.

**Component no. 3: Jail Visit/ Chamber Visit - 30 marks**

Students should write a detailed report on Jail Visit / Chamber Visit to Lawyer' office and the functioning of the office, pre-trial preparations, client counselling etc.

**Viva - 10 marks**

The examiner will conduct Viva based on the above 3 components.

Students shall adhere to the schedule given on next page for Compulsory Moot Court and Viva.

**The dress code will be Black and White Formals (I-card Compulsory)**
