1.3 CRITERIA WISE SUMMARY

Curricular Aspects

As our institute is affiliated to University of Mumbai, the syllabus provided by university and date of commencement of semester and end semester date faculty members taught theory subjects and conducts practical knowledge accordingly. The Academic Monitoring Committee (AMC) is formed for the smooth implementation of the Curriculum and the Academic Calendar given by the University throughout the academic year. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The college organizes events and celebrate days, in which the college specifically considers the inclusivity of different cultures and regional, linguistic development for example the literature committee of the college had organized an event called "many languages one tongue", which specifically put forth many stories from regional languages along with their translations in English for everyone to understand. Cultural committee of the college every year organizes traditional day where in students just don't have to wear the traditional attire but also explain the culture of that specific region which they have picked and why so. This gives a scope to students to research about other cultures and the diversity, differences and similarities. Students are encouraged in the classroom to participate in the discussions and answer the questions put forth by teachers in the regional language as well, specifically the students who haven't quite grasped the expertise on their English. This practice helps students to increase the confidence; wherein the teacher helps correct the misconceptions which the students may have in their understanding of the subject. This is rather a very good example of Localization and personalization adopted by our teachers to make education an inclusive process.
5. Response:

The college provides a three-year LL.B. and a five-year BLS LLB programme. The curriculum for these courses is based on the recommendations of the University of Mumbai's syllabus review committee. All teaching faculties are told about the subjects they will be teaching prior to the start of each academic year so that they can have a comprehensive understanding and preparation.

The principal hosts a staff meeting to organise the upcoming academic year. On this basis, the creation of a schedule, which is approved by the principal, generates a comprehensive timetable in accordance with the University of Mumbai's term arrangement to establish a balance between educational, co-curricular, and extra-curricular activities. The timetable is created, implemented, and overseen by all faculty members in collaboration with the principal. The principal conducts regular staff meetings to make sure smooth functioning of lectures. The teaching hour workload is divided among the full-time faculty members, with the remaining hours allotted to visiting faculty.

The teaching faculty was given training on the use of online platforms and various online teaching aids. Class groups were created on whats app and the same was used effectively to communicate with students and also for sharing study material. The University of Mumbai's curriculum is structured in such a way that it incorporates all of the cross-cutting issues relevant to the NAAC Metrics into the curriculum through courses such as Practical Training, Labour Law, and Professional Ethics, ADR, Constitutional Law, and Environmental Law are

just a few examples.

The topic of Professional Ethics and the Advocates Act, 1961 is covered in the **Practical Training I** course in order to comprehend the attributes of competent lawyers, the obligation they have to their client, the court, the opposing counsel, and the rights they have. It educates students the consequences of professional misconduct and the disciplinary procedures that can be taken against them. It also makes it easier to grasp the fundamental ethical norms of the legal profession.

Subjects like **Labour Law and Alternative Dispute Resolution** give a better understanding of the outof-court settlement measures that are available at both the national and international levels. These measures include Collective Bargaining, Mediation, Conciliation, and Arbitration. This not only assists in bringing about a situation in which both parties benefit, but it also assists in maintaining positive relations between those who disagree, thereby instilling Human Values such as consideration, openness, and fairness.

Human Values are also emphasized in courses such as Legal Language and Legal Writing, Administrative Law, English II, Sociology, Political Science III, History, Public International Law, Human Rights, Family Law, Law of Crimes, Law and Medicine, Jurisprudence, and Constitutional Law.

Constitutional Law is a mandatory subject that familiarises students with Fundamental Rights, Directive Principles of State Policy, Fundamental Duties, and Constitutional and Statutory Remedies that address this issue. This course focuses on gender issues. Gender roles in diverse groups are also discussed in Women's and Children's Law, History, Sociology, Political Science II, Family Law I and II, as well as Legal Language and Legal Writing.

Environmental challenges have reached frightening dimensions; it is vital that students learn about environmental issues and laws. The **Environmental Law** course is intended to equip future attorneys to deal with environmental challenges. This course also ensures that students are aware of rising environmental challenges and the solutions that are available. Sustainable Development, the Doctrine of Public Trust, the Precautionary Principle, the Polluter Pays Principle, and various National and International Laws are taught to students, keeping them up to date on the various Environmental issues and legal remedies available.

Classrooms discussions are held and students are also encouraged to explore different aspects of legal subjects by assigning innovative and practical based assignments as the part of their internal assessment.
