Note:

1) Eligibility for admission to the THIRD YEAR B.A.LL.B.:

- Sem. I & Sem. II: Student should have compulsory cleared all subjects.
- Sem. III and Sem. IV, up to TWO A.T.K.T. are allowed.

2) ABC ID is mandatory for filling the Admission form. Instructions regarding generating ABC ID are available on the college website – 'Admission' Tab.

3) Admission form is available on the college website. Students should fill the form online, upload the required documents and make online payment of Rs. 100/- for the admission form through college website.

Students are required to upload the following while filling the online admission form:

- (a) Photocopies of Marks Sheets (Sem. I & III) & Statement of Marks (Sem. IV).
It is mandatory to upload the original marksheets of all previous years and in case you do not have any previous year marksheet of any semester, then you should upload the statement of marks. Statement of marks full page should be uploaded, do not crop it.
- (b) Photograph & Signature (In JPEG/JPG/PNG up to size 1MB) as mentioned in the admission form.

4) Fee for the academic year 2026-27 is Rs. 26,500/- (Rupees-Twenty-Six Thousand Five Hundred Only).

5) The student must report to the college on the above mentioned days and time for verification of documents and confirmation of admission.

6) Students must carry the following documents while reporting to college:

- A print out of the duly filled admission form.
- Photocopies of Marks Sheets (Sem. I to II) & Statement of Marks (Sem. III & IV).

7) After verification of documents, fees will be assigned to the students which should be paid immediately.
