After reporting to the college and completing the verification of original documents, students shall complete the admission process by following the steps given below:

Admission Procedure:

Step 1: Fill the Anti-Ragging Undertaking

Complete the Anti-Ragging Undertaking online to generate the **Anti-Ragging Reference Number**, which is mandatory while filling the College Admission Form. (Websites: www.antiragging.in & www.amanmovement.org)

Step 2: Create/Generate Academic Bank of Credits (ABC) ID

Students must create or obtain their **Academic Bank of Credits (ABC) ID**. Instructions for generating the ABC ID are available under the 'Admission' tab on the college website. The **ABC ID Number** is mandatory for completing the College Admission Form.

Step 3: Fill the College Admission Form & Pay Admission Processing Fee

Complete the online College Admission Form and pay the **Admission Processing Fee of ₹100/-** through the college website: (www.abalawcollege.edu.in)

Step 4: Submission of Admission Form & Original Documents

Submit the printed copy of the completed College Admission Form along with the required original documents to the College Office on the scheduled reporting date for verification.

Students are advised to carry all original documents along with one set of self-attested photocopies to facilitate the verification process.
