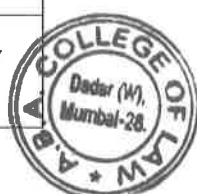
All the following Eligibility students have not yet submitted **Mark sheet Verification Report & Migration Certificate** of their previous University to the college.
